## Certification of Nevada Residency

This certification is used to support a claim that you are a Nevada resident. You must be a resident of Nevada to be eligible for a driver's license or identification card (NRS 483.250 (7), 483.290 (5)(b), and 483.934). The definition of "resident" is found in NRS 483.141.

This certification will be accepted as one form of evidence for your principal residence address.

**For individuals residing in Nevada, one of the following forms of documented proof is also required and must be submitted with this form:**

- A property tax record, utility bills, mortgage document or Deed, rent receipts, a lease or rental agreement;
- Enrollment records, student identification card reflecting the residence address, or other documentation that you are physically attending an educational institution located in Nevada;
- Motel, hotel, campground or recreational vehicle park receipts showing that you have been residing in Nevada for 30 consecutive days;
- Original and current certificate of vehicle liability insurance reflecting the residence addresses issued by a Nevada based carrier. Cannot be hand-written;
- Credit card statement, medical bills, cellular telephone bill, or other statement or request for payment mailed to the residence address dated within the previous 60 days;
- A statement from a relief agency or shelter (Form DMV115) that you have no actual residence, but currently receive assistance in Nevada, dated within the previous 60 days;
- Fuel receipts, motel receipts, or other documents showing you have lived in multiple states (more than two) during the last 12 months, and in Nevada for at least 30 consecutive days, as evidence that you do not primarily reside in some other state;
- Voter registration card issued by the Nevada Secretary of State for the most recent election period reflecting the residence address;
- Documents showing you have a current account at a bank or credit union in Nevada and the account has been open for 30 days or more;
- Military Leave and Earnings Statement (LES) to evidence Nevada residency when deployed outside of Nevada;
- Notarized statement from the owner of property located in this State indicating that the person physically resides at that property without a lease or rental agreement. The Homeowner Residency Affidavit (DMV116) may be used but is not required.
- A document showing receipt of public assistance from an agency of the State of Nevada dated within the previous 60 days;

*This certification must be signed by a second party attesting to Nevada residency if the applicant is not able to produce one of the above required documents with this certification. The second party must reside at the same residence address, accompany the applicant, and present proof of residency in the form of one document listed above.*

**DISCLOSURE STATEMENT:** The Privacy Act as passed by the United States Congress authorizes the use of your Social Security number for the purpose of verifying your identity. This number must be provided and will be used in the administration of driver license laws as required by NRS 483.290.

**I hereby certify under penalty of perjury that all statements in this application are true and correct. I agree and understand that any misstatement of material facts may cause cancellation and/or denial of my driver license or identification card under NRS 483.420 and NRS 483.530, respectively. I further understand that any misstatement of facts may be a misdemeanor or felony under NRS 483.530, and may be punishable pursuant to NRS 193.130.**
