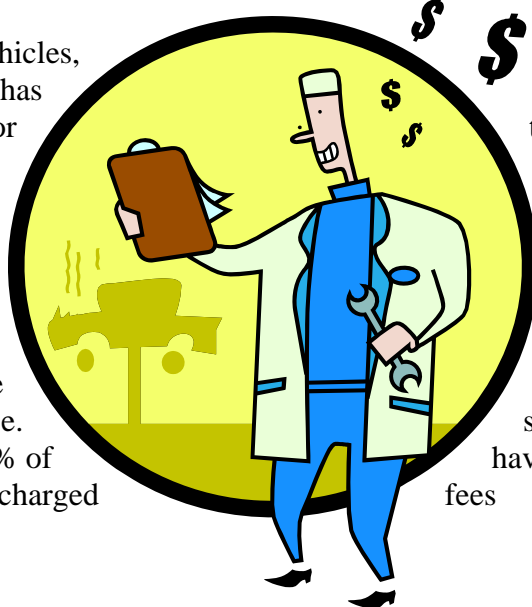

Labor Rate Survey Results Clark and Washoe Counties

The Department of Motor Vehicles, Emission Control Section has completed the 2007 annual labor rate survey for both Washoe and Clark Counties as required by NAC 445B.599. This survey is sent to all repair facilities, within the I/M Program to determine the maximum fee that may be charged for an inspection and the issuing evidence of compliance. This is accomplished by taking 35% of the average hourly shop labor rate charged



by authorized stations within the county and rounding the result to the nearest 50 cents. A questionnaire/survey was mailed to all authorized stations on October 05, 2007, for information regarding hourly labor rates charged for repairs to both light and heavy-duty motor vehicles. Fifty percent of the stations surveyed in each county have responded. Listed below are the fees for calendar year 2008.

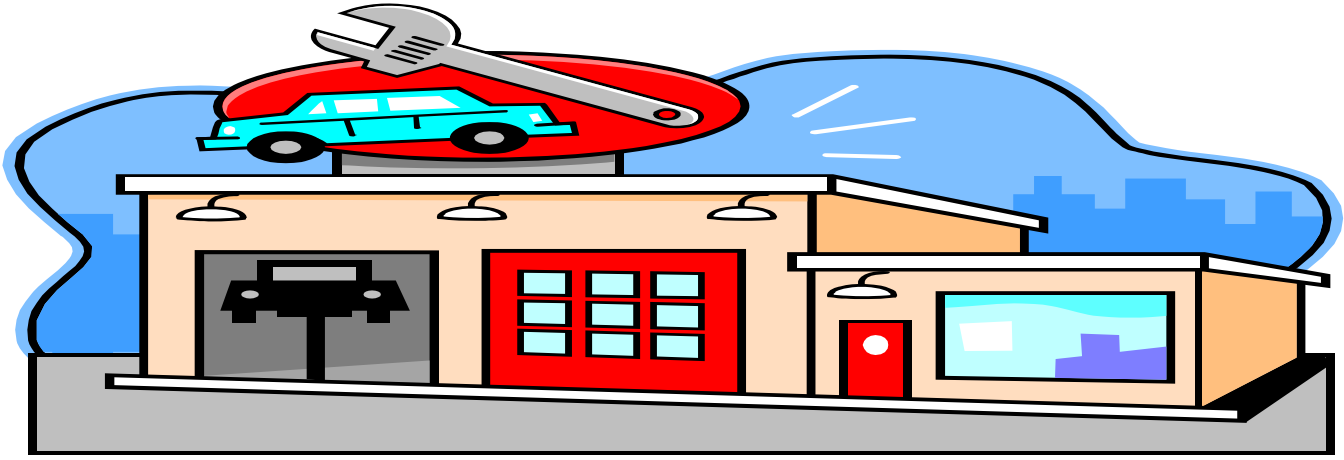
