

Please read this information sheet while you wait for your number to be called.

Listen for your number to be called and make sure you have all the required documents listed for your transaction. If you do not have the required documents, you will not be able to complete your transaction. Please read carefully and make sure you are prepared because no return passes will be issued. You may visit our website at www.dmvnv.com for additional information.

Applying for First Time Nevada Driver's License, Instruction Permit or Identification card:

Complete both sides of yellow form.

Proof of Name and Date of birth:

- U.S. original or certified birth certificate (hospital birth certificates or photo copies are not accepted) or;
- U.S. passport or U.S. military ID or;
- Certificate of Citizenship or Naturalization or;
- Permanent or Temporary Resident Card or;
- Valid resident Alien Card/I-551 /I-94 with Visa

Proof of any name changes (photo copies are not accepted):

- Original or certified copies of marriage certificate or;
- Original or certified copies of divorce decree or;
- Original or certified copies of court documents

Proof of Social Security Number:

- Must be in your current name
- Social Security Card or;
- W-2, 1099 or 1099A or;
- Completed tax return

Your current out-of-state driver license, instruction permit or identification card.

Renewing and/or Reinstating an existing Nevada Driver License, Instruction Permit or ID Card:

Complete both sides of the yellow form.

- Previous Nevada card or proof of name and date of birth as listed above or a photo on file and;
- SR-22 and/or clearance letter if required.

Applying for a Duplicate Nevada Driver License, Instruction Permit or Identification Card:

Complete both sides of the yellow form.

- Proof of name and date of birth as listed above or a photo on file.

Applying for a name change:

Complete both sides of the yellow form.

- Original or certified copies of all marriage certificates and;
- Original or certified copies of all divorce decrees and;
- Original or certified copies of court documents.

Change of Address:

Complete both sides of the yellow form.

- Valid Nevada card or proof of name and date of birth as listed above or photo on file.

Vehicle Registration (all transactions):

- Nevada Insurance Card matching VIN, the vehicle description and registered names and;
- Nevada smog (if applicable) and;
- Plates if transferring from another vehicle and;
- DMV form VP222 if you are processing a transaction for someone other than yourself.
- The residential and mailing address for all registered owners.

If purchased from:

A Nevada Dealer:

- Dealers Report of Sale (green form)

Private Party:

- Title properly endorsed and;
- Bill of sale for multiple transfers of ownership or;
- Security agreement from lien holder and;
- VIN inspection if out of state vehicle.

Out of state dealer:

- Purchase agreement and;
- Title properly endorsed and;
- Bill of sale for multiple transfers of ownership and;
- VIN inspection.

Coming from another state:

- Current out of state registration and;
- Out of state plates (remove and bring in) and;
- VIN Inspection

Title only transaction:

- Title properly endorsed and;
- Bill of sale for multiple transfers of ownership and;
- VIN inspection for out of state vehicle.

Vehicle Suspensions:

- Nevada insurance card matching the vehicle's identification number, vehicle description and names and;
- Nevada smog (if applicable) and;
- Proof of non-operation if applicable.

Renewal of Nevada vehicle registration:

- Nevada insurance card matching the vehicle's identification number, vehicle description and name(s) and;
- Nevada smog (if applicable).
