REPLACEMENT LICENSE PLATE APPLICATION

NRS 482.2715

Definition: A license plate or set of license plates that has expired and has remained expired for a continuous period longer than 18 months. A Replacement license plate may be issued in either a Standard or Special Counter license plate format.

The combination of letters and numbers requested must have been previously issued and expired for 18 months or the previous registrant must release his or her interest in the requested license plate. The release of interest must be in the form of a statement that includes the license plate number. The statement must be notarized or witnessed by an authorized Nevada DMV Representative. If the license plate was registered to the applicant, but has been expired for 18 months, this application must be completed and the appropriate fees collected.

A Replacement License Plate may not be personalized.

The fee for a standard Replacement License Plate is \$27.00, which includes a Prison Industry fee of 50 cents per plate along with a Technology fee of \$1.00. Additional fees for specialty Replacement License Plates depend on associated sponsoring agency fees. These fees are in addition to all other applicable fees.

The Replacement License Plate(s) will be mailed to the current address of record maintained by the Department. If you ordered your Replacement License Plate via mail, your plates will be forwarded to the DMV Location specified on the application and you will be notified, by mail, when the plate is available to be picked up. If your vehicle is currently registered, you have the option of maintaining your current vehicle registration expiration date, or renewing for a full 12-month period. Credit for any unused portion of your current registration will be allowed. In applicable counties, if you are renewing for a full 12-month period, and your previous evidence of compliance with emissions standards was obtained more than 90 days ago, the vehicle must be re-inspected prior to registration.
