

NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Public Hearing for the Adoption of Proposed New and Amended Regulations of the Department of Motor Vehicles

The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to chapter 485 of the Nevada Administrative Code.

Proposed Regulations of the Department of Motor Vehicles, LCB [File No R171-09](#)
(Note this regulation was previously assigned as R133-09, that file has been closed)

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment.

These changes are being made to be compliant with 2009 Legislative [Senate Bill 312](#) requiring the validation of current liability insurance coverage for each vehicle actively registered in Nevada. The proposed amendments revise the reporting requirements for insurance companies. Insurance companies will have several methods for reporting, each with specific data requirements. The proposed amendments describe the responsibilities for registered owners to ensure their insurance record is current with the Department of Motor Vehicles.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved.

The Department is required by statute to amend regulations relating to the administration and enforcement of the validation of liability insurance coverage for each vehicle actively registered in Nevada.

3. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:

(a) Both adverse and beneficial effects. There is no estimated economic effect.
and

(b) Both immediate and long-term effects. There is no estimated economic effect.

4. The estimated cost to the agency for enforcement of the proposed regulation.

There is no cost to the Department in the enforcement of these proposed regulations.

5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

The proposed amendments to the regulations do not overlap that of any other state, local, or federal government agency.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

These regulations are not required pursuant to federal law.

7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.

The proposed amendment does not include provisions which are more stringent than a federal regulation.

8. Whether the proposed regulation establishes a new fee or increases an existing fee.

The proposed amendment does not establish a new fee or increase of an existing fee.

Written submission must be received by Department of Motor Vehicles on or before **Tuesday, March 16, 2010**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be Amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and regulations to be Amended will be available at each of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://leg.state.nv.us/Register/>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
