1. The establishment of regulations in the Nevada Administrative Code relating to the assessment and collection of a non-refundable processing fee for each transaction completed on self-service terminals (kiosks). The processing fee is in addition to all other applicable fees and taxes.
2. The fees shall not exceed those in the contract awarded in accordance with the requirements of NRS 333 to the supplier of the self-service terminals or kiosks.
