The purpose of the workshop is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations. These regulations are being proposed pursuant to Senate Bill 323 which was passed in the 2011 Legislative Session. Items will be discussed in the order listed:

1. Certificate of Financial Responsibility (SR-22) and suspension of driver's license for additional insurance lapse violations.
2. Five-Year record limitation for counting insurance lapse violations.
3. Request for hearing for suspension of vehicle registration as a result of lack or lapse of insurance.
4. Inclusion of insurance lapse days not in original request to registered owner.
5. Removing insurance companies' requirement to submit insurance records, to enhance the web services process.
