

## NOTICE OF INTENT TO ACT UPON A REGULATION

### Notice of Public Hearing for the Adoption of Proposed New Regulations of the Department of Motor Vehicles

The purpose of the hearing is to solicit comments from all interested persons regarding the adoption of amendments that pertain to Chapter 485 of the Nevada Administrative Code. Items will be discussed in the order listed:

Proposed Regulations of the Department of Motor Vehicles, [LCB File No R045-12](#)

The following information is provided pursuant to the requirements of NRS 233B.0603:

**1. The need for and the purpose of the proposed regulation or amendment.**

These regulations are necessary for the purpose of administering the Department's insurance verification program; NV LIVE.

**2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved.**

**NAC 485.153**

- In subsection 1, the Department is proposing to delete "effective date" from the notification to the Department of the issuance, amendment or termination of a policy.
- In subsection 4, the Department is proposing to add the provision that insurers submit insurance policy records, issued or amended during the previous month, by the seventh day of each month, and in the manner prescribed in the list of specifications published on the Department's website.
- In subsection 5, if the data file submitted by the insurer does not match the published specifications, the data file will be deleted and the insurer will be notified by electronic mail. The insurer will then resubmit the data file using the correct specifications within five (5) business days after notification of the deleted data file.

**NAC 485.175**

- In subsection 1, the Department is proposing to amend provisions of non-compliance to include failing to maintain the information required in a record pursuant to NAC 485.155; confirming a policy that does not meet the requirements of NRS 485.185 and 485.186, violating provisions of NAC 485.175 relating to the maintenance of or access to records pursuant to NRS 485.314.

**NAC 485.170**

- The Department is proposing to repeal this provision since it is being amended and added as subsection 5 in NAC 485.153.

**3. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:**

**(a) Both adverse and beneficial effects.** There is no economic effect on business. There is no economic effect on the public.

**and**

**(b) Both immediate and long-term effects.** There is no economic effect on business. There is no economic effect on the public.

**4. The estimated cost to the agency for enforcement of the proposed regulation.**

There is no cost to the Department in the enforcement of these proposed regulations.

**5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.**

The proposed amendments to the regulations do not overlap that of any other state, local, or federal government agency.

**6. If the regulation is required pursuant to federal law, a citation and description of the federal law.**

These regulations are not required pursuant to federal law.

**7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.**

The proposed amendment does not include provisions which are more stringent than a federal regulation.

**8. Whether the proposed regulation establishes a new fee or increases an existing fee.**

The proposed regulation does not establish any new fees or any increases in existing fees.

Written submission must be received by Department of Motor Vehicles on or before **Thursday September 13, 2012**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and regulations to be adopted will be available at each of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://leg.state.nv.us/Register/>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
