The purpose of the hearing is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations.

Section 1 of Chapter 235 of the Statutes of Nevada 2015, at page 1115, authorizes the Department of Motor Vehicles to adopt regulations to allow bona fide farmers or ranchers to claim a refund of 80 percent of the taxes paid on bulk purchases of special fuel.

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the public hearing. Because of time considerations, the period for public comment by each speaker may be limited.
