The purpose of the workshop is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations.

NRS 482A.100(1) requires the Department of Motor Vehicles to adopt regulations authorizing the operation of autonomous vehicles within the State of Nevada.

NRS 482A.100(2)(f) set forth such other requirements as the Department determines to be necessary.

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the public hearing. Because of time considerations, the period for public comment by each speaker may be limited.

ITEMS FOR CONSIDERATION

- Control of an autonomous test vehicle by a natural person
- Expanding the requirements for certain operators of autonomous test vehicles
- Definition of “active control” and “physical control”
