The purpose of this Hearing is to receive comments from interested persons regarding the adoption of amendments that pertain to Chapters 481 and 483 of the Nevada Administrative Code. These regulations are being proposed pursuant to:

NRS 481.051(3)(c) requires the Department of Motor Vehicles to adopt regulations consistent with law for the operation of the Department and the enforcement of all laws administered by the Department.

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the workshop. Because of time considerations, the period for public comment by each speaker may be limited.

ITEMS FOR CONSIDERATION

- Section 13 of Assembly Bill 68 clarifies the fees charged for these identification cards. The Department of Motor Vehicles has revised the expiration dates for an identification card issued to persons aged 65 and older.
- Section 2 through 4 of Assembly Bill 252, authorizes the Department of Motor Vehicles to adopt regulations to set criteria for issuance or refusal of issuance of an identification card, driver's license or commercial driver's license that displays an alternate address.
- Section 19 of Senate Bill 215 authorizes the Department of Motor Vehicles to adopt regulations prescribing the addition of documents an applicant may use to furnish proof of his or her full legal name.
- Revisions are being made to clarify when the mailing address is able to be placed on a driver's license or identification card issued by the Department of Motor Vehicles.
- Cleanup was added regarding when the "K" restriction is to be placed on a CDL.
- Cleanup added to change the gender change process from a medical certification to a self-attestation.
- Revisions were made to NAC 483.050 to allow the acceptance of older version I-551 documents issued by the Department of Homeland Security.
