The purpose of the hearing is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations.

Section 6 of Senate Bill 31 of the 2017 Legislative Session, at page 4, authorizes the Department of Motor Vehicles to adopt regulations revising the requirements for registration of certain commercial motor vehicles, adoption of penalties, and revision of registration documentation and administrative duties associated with this.

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the hearing. Because of time considerations, the period for public comment by each speaker may be limited.

ITEMS FOR CONSIDERATION

- Criteria and provisions relating to out-of-service orders for motor carriers and changes to registration documentation, movement from a \$6 per decal fee to a flat \$25 license fee associated with administration of motor carrier activities.
