The purpose of the workshop is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations.

- Section 2 adds the definition of an Autonomous Vehicle Certification Facility
- Section 3 defines the certificate of compliance required for autonomous technology approved for testing and operation in Nevada
- Section 4 defines the requirements for an autonomous vehicle to be tested or operated on Nevada roads
- Section 5 provides the DMV a process for keeping certain information regarding autonomous technology confidential

- Section 7 clarifying and updating the requirements that a vehicle must be registered in Nevada prior to being operated autonomously and not in a testing environment.
- Section 8 updates the requirements to be met prior to testing an autonomous vehicle in Nevada
- Sections 9 – 16 update the requirements for an autonomous vehicle certification facility to meet prior to certifying an autonomous vehicle
- Section 17 removes the requirement for a G endorsement to operate an autonomous vehicle

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the workshop. Because of time considerations, the period for public comment by each speaker may be limited.
