

**NOTICE**  
**Availability of start-up funding to Administer the Provisions of**  
**Senate Bill 394**  
**2009 Legislative Session**

As required by Section 62.5 of [Senate Bill 394 from the 2009 Legislative Session](#), the Department of Motor Vehicles (Department), is posting notice that at least \$500,000 is available to the Department to administer provisions of chapter 490 of Nevada Revised Statutes relating to the registration and titling of off-highway vehicles. In accordance with the Interim Finance Committee's direction, the Department was notified that as of January 12, 2011, funding was available in the Revolving Account for the Assistance of the Department created by section 19.5 of Senate Bill 394.

The purpose of this notification is to inform members of the public the funds have become available to the Department of Motor Vehicles and work will begin to implement the provision of Senate Bill 394. Major provisions of the bill the Department will use the start-up funds to implement include:

1. Requiring certain owners of an off-highway vehicle (OHV) to apply to the Department for a certificate of title and registration (NRS 490.082).
2. Allowing an owner of certain off highway vehicles to apply to the Department for a certificate of title and requiring registration (NRS 490.082).
3. Requiring OHV dealers to be licensed through the Department (NRS 490.200).
4. OHV dealers will be regulated by the Department (NRS 490.210 through 490.410).
5. Requiring OHV salesmen to be licensed and regulated through the Department (NRS 490.420).
