## ITEMS FOR CONSIDERATION

### **LCB File No. R023-18**

- Public Comment
- Senate Bill 452 of the 79<sup>th</sup> Session, authorizes a person who is unable to provide information satisfactory to the Department that the person is entitled to a certificate of title or a duplicate or substitute certificate of title for a vehicle to obtain a new certificate of title by:
  - Filing a bond with the Department in an amount equal to one and one-half times the value of the vehicle, as determined by the Department,
  - Allowing the Department to inspect the vehicle to verify the vehicle identification number and the identification numbers, if any, for parts used to repair the vehicle; and
  - Authorizing the Department to conduct a vehicle history search through relevant national crime information systems.
- NAC 482.295 Sets the fee amount the Department is authorized to charge for license plates.
